Second Amendment to THE PARTNERSHIP ARRANGEMENT Between

THE DIRECTORATE GENERAL FOR ITALIAN CITIZENS ABROAD AND MIGRATION POLICIES OF THE ITALIAN MINISTRY OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION And THE INTERNATIONAL ORGANIZATION FOR MIGRATION On

ENHANCING RESPONSE MECHANISMS AND ASSISTANCE OF VULNERABLE MIGRANTS IN TUNISIA

Preamble

The International Organization for Migration ("IOM"), a related organization of the United Nations, and the Directorate General for Italian Citizens Abroad and Migration Policies of the Italian Ministry of Foreign Affairs and International Cooperation (hereinafter referred to as "Donor") have entered into a Partnership Arrangement on the Project "Enhancing Response Mechanisms and Assistance of Vulnerable Migrants in Tunisia" on 26 November 2021 as amended on 9 December 2022 (hereinafter the "Arrangement"). IOM and the Donor are also hereinafter referred to individually as a "Party" and collectively as the "Parties".

The Parties now seek to amend the Arrangement as follows:

- 1. Article 2.2 of the Arrangement is deleted and replaced with the following:
 - 2.2 The following documents form an integral part of this Arrangement:
 - (a) Annex A- Project Document, Work Plan and Project Budget;
 - (b) Revised Annex A- Revised Project Document, Work Plan and Project Budget; and
 - (c) 2^{nd} Revised Annex A 2^{nd} Revised Project Document, Work Plan and Project Budget.
- 2. Article 2.3 of the Arrangement is deleted and replaced with the following:
 - "2.3 The duration of the Project shall be for a period of **36 months** from **1 March 2022 to 28 February 2025.**

The remainder of Article 2 does not change.

3. The following sentence shall be added to Article 3.1 of the Arrangement as follows:

"The Donor will provide additional funding to IOM for a total amount of **EUR 3,000,000.00** (Three Million Euros only), bringing the Contribution to a total of **EUR 6,150,000.00** (Six Million One Hundred Fifty Thousand Euros only)".

The remainder of Article 3 does not change.

4. The following sentence shall be added to Article 3.3 of the Arrangement as follows:

"The Additional Contribution shall be paid by the Donor in one instalment within 60 (sixty) days from the date of signature of this Amendment to the following account in Euros (EUR), quoting the above IOM [Reference number/project code] to facilitate the recording of the Contribution into IOM's EUR accounts:

5. The following sentence shall be added to Article 3.8 of the Arrangement as follows:

The Additional Coordination Levy for this Amendment is **EUR 29,703.00** (Twenty-Nine Thousand Seven Hundred Three Euros only), bringing the Coordination Levy to a total of **EUR 60,891.00** (Sixty Thousand Eight Hundred Ninety-One Euros only). The Additional amount will be transferred to IOM at the bank account mentioned above upon receipt of the signed Amendment to the Arrangement.

The remainder of Article 3 does not change.

- 6. All other articles remain unchanged.
- 7. All other terms and conditions of the Arrangement remain in force.
- 8. Nothing in or relating to this Amendment or the Arrangement shall be deemed a waiver, express or implied, of any of the privileges and immunities of the International Organization for Migration as an intergovernmental organization.

9. This Amendment enters into force on the date of the last signature of the Parties.
