**Amendment to
THE PARTNERSHIP AGREEMENT
Between
THE DIRECTORATE GENERAL FOR ITALIAN CITIZENS ABROAD AND MIGRATION POLICIES OF
THE ITALIAN MINISTRY OF FOREIGN AFFAIRS AND INTERNATIONAL COOPERATION
And
THE INTERNATIONAL ORGANIZATION FOR MIGRATION**

Preamble

The International Organization for Migration ("IOM"), an organization part of the United Nations system, and the Directorate General for Italian Citizens Abroad and Migration Policies of the Italian Ministry of Foreign Affairs and International Cooperation (hereinafter referred to as "Donor") (also individually referred to as a "Party" and collectively as the "Parties") have entered into a Partnership Agreement on 4 August 2017 (hereinafter the "Agreement").

The Parties now seek to amend the Agreement as follows:

1. The following sentence shall be added to Article 3.1 of the Agreement:

"The Donor will provide additional funding to IOM for a total amount of EUR 2,000,000.00 (Two Million Euros only) which shall be paid in one instalment within 60 (sixty) days from the date of signature of this Amendment."

The remainder of Article 3.1 does not change.

2. Articles 4.1 and 4.2 of the Agreement are deleted and replaced with the following:

"4.1 The Contribution shall be used to implement the following Activities under the Action Plan for the specified amounts:

- a) Voluntary Humanitarian Return and Reintegration of Migrants Stranded and Detained in Libya, as of point 1.3.1 of the Action Plan, for a total amount of EUR 11,000,000.00 (Eleven Million Euros only).
- b) Promoting rights-based solutions for vulnerable migrants through a Migrant Resource and Response Mechanism (MRRM) in Libya, as of point 1.3.2 of the Action Plan for a total amount of EUR 3,000,000.00 (Three Million Euros only).
- c) Stability and resilience enhancement through the Community Stabilization Program in targeted Libyan communities, as of point 2.2 of the Action Plan, for a total amount of EUR 6,000,000.00 (Six Million Euros only).

- 4.2 The Activities described in Article 4.1 shall be carried out by IOM according to the initial and revised Concept Notes and relevant work-plans and budgets. The revised Concept

Notes shall be valid from the date of this Amendment and which forms an integral part of the Agreement.


3. All other terms and conditions of the Agreement remain in force.
4. Nothing in or relating to this Amendment or the Agreement shall be deemed a waiver, express or implied, of any of the privileges and immunities of the International Organization for Migration as an intergovernmental organization.
5. This Amendment enters into force on the date of the last signature of the Parties.
